JUSTICE LODGE #285 F & AM Educational Trust

Justice Lodge No. 285, F & A.M. of Linwood, N.J., established a Scholarship Foundation consistent with the ideals of Justice Lodge and its policies of furthering the educational advancement of worthy high school or college graduates, possessing those qualities of mind and character, which hold promise of social usefulness and civic leadership.

The Educational Trust is established expressly for the purpose of assisting the son, daughter, grandson or granddaughter or legally adopted child of a Master Mason in the twenty–third Masonic District of the State of New Jersey.

The recipient of the award must enroll in an accredited community college, college or university and attend courses leading to a degree. Where the scholarship holder is accepted to enter a postgraduate program prior to or after the completion of his/her undergraduate program, he/she may do so by reapplying to the Scholarship Selection Committee for a post graduate scholarship.

The recipient shall maintain a scholastic average consistent with the high standards of the Scholarship Award. Official reports may be required at the completion of each semester.

Applicants will be judged on the basis of the following qualifications:

- Character
 - Applicant shall possess exemplary moral character and habits.
- Scholarship

Applicants shall demonstrate evidence of a sufficient level of academic achievement that will assure admission to an institution of higher learning.

- Religious Consciousness
 - Evidence of a consciousness and appreciation for his/her religious and cultural heritage.
- Financial Need

The presentation of facts indicating need for financial assistance to pursue higher education.

Interview:

Finalists will be required to participate in an interview with the members of the Selection Committee.

APPLICATIONS

- 1. Applications shall be submitted on forms furnished by the Scholarship Selection Committee to be received by the Committee no later than April 18, 2022.
- 2. Application forms may be obtained from the High School Guidance Department, the Secretary of any of the Masonic Lodges in the 23rd Masonic District*, or the address at the bottom of this letter.
- 3. Incomplete applications, or applications received by the Committee after April 18th will not be considered.
- 4. Annual presentation of the award(s) shall be made at a time and place to be determined by the Scholarship Selection Committee.
